Description of Information or Material Fact	<p>The Company's subsidiaries, which are PT Meares Soputan Mining ("MSM") and PT Tambang Tondano Nusajaya ("TTN"), and PT Hanwha Mining Service Indonesia, third party company, signed Contract of Supply Service dated 1 October 2021.</p> <p>PT Hanwha Mining Service Indonesia provides drilling services to support MSM and TTN business activities/operations, which include blasthole services, grade control drilling and other services, with estimated contract value of Rp663.5 billion (six hundred sixty three point five billion Rupiah) within periods of approximately 5 (five) years (1 October 2021 to 25 August 2026).</p> <p>MSM and TTN have a same Contract of Supply Service with other Contractor with service periods starting on 1 July 2015 and will end on 28 February 2022. Drilling service costs in 2020 were approximately US\$6.7 million (six point seven million United States Dollar) or equivalent to Rp97.2 billion (ninety seven point two billion Rupiah).</p>

Impact for such Information or Material Fact towards operational activity, legal, financial condition or business continuity of Issuer or Public Company	<p>The Contract of Supply Service is services for routine, repeatedly and/or continuously business activities by MSM and TTN, therefore it will not have significant impacts to legal, financial condition or sustainability of the Company and subsidiaries' business activities.</p> <p>Furthermore, the Company believes that this Contract will give positive impacts to MSM and TTN business activities.</p>
